



## **Responsibilities of CACCI Officers**

### **A. PRESIDENT**

1. The CACCI President shall serve as the chief executive officer of the Confederation. He shall preside over the meetings of the CACCI Council and the CACCI Conferences. He shall supervise the operations of the Confederation and report to the CACCI Council.
2. The incumbent President of the Confederation shall be an ex-officio member of the Advisory Board. Composed of Past Presidents of CACCI, the Advisory Board suggests measures for the improvement of the Confederation and its structure; offer solutions to problems whenever they arise; and give advice on matters where such is sought by the officers of the Confederation
3. The incumbent President of the Confederation shall be an ex-officio member of Budget Commission. The Budget Commission is responsible for preparing and presenting the Annual Budget of the Confederation, reviewing the income and expenditures, and formulating ways and means of providing the financial requirements of the Confederation.
4. In case of a temporary leave of absence, the President shall designate one of the Vice-Presidents to act for him and in his behalf. In the event the President shall cease to discharge his office by reason of death, resignation, removal or incapacity, the Primary Member from which he comes shall be entitled to fill the vacancy by designating another of its representatives to serve as President of the Confederation for the unexpired term.
5. At the expiration of his term of office, the President shall not be eligible for re-election to the same office for the next two (2) years except by a two-thirds majority vote of the Primary Members of the Council.
6. The President shall preside over the CACCI Planning Committee Meeting which discusses preparations for the annual meeting and conference.
7. The President shall visit as many Primary Members as possible during his term – at least five Primary Members annually. Through these visits, the President will endeavour to gather first-hand information on the business situation in the host country; further build up the image of CACCI by making courtesy calls on heads of states, ministers, and other high-ranking government officials; and meet top businessmen in the host country. The countries to be visited are decided by the President himself in consultation with the Secretariat.
8. The President shall represent CACCI at key regional or international forums, conferences, seminars and other events where the Confederation is invited, either as speaker, resource person or special guest – or designates another member (usually another officer or appropriate member of the CACCI Council) to attend these events on his/her behalf

9. The CACCI President is expected to finance his travel when he attends CACCI Council Meetings and Conferences, CACCI Planning Committee Meetings, regional or international forums, as well as when goes on Presidential visits. The Secretariat will provide him support by making all the arrangements, in coordination with the host chambers and organizations.

10. The CACCI President is requested to make a voluntary donation of US\$20,000 annually to the general fund of CACCI

11. The CACCI President or his Chamber is requested to contribute US\$20,000 to the CACCI Foundation on voluntary basis.

***Note: It is advisable that the candidate for President has served at least one term as Vice President before assuming the Presidency.***

## **B. VICE PRESIDENTS**

The Vice Presidents shall assist the President in promoting the purposes of the Confederation. Each Vice President is designated to be responsible for one of the following functional areas (or any other areas as may be determined by the CACCI Council):

- ⤴ Policy advocacy
- ⤴ Liaison with other regional and international business organizations (e.g., ICC WCF, Eurochambres, Junior CC, etc.)
- ⤴ Strengthening relationship with Organizations involved in regional cooperation efforts (e.g., ASEAN, APEC, SAARC, etc.)
- ⤴ Promoting trade and investment among CACCI member countries (e.g., Trade fairs and exhibitions)
- ⤴ Membership Expansion
- ⤴ Training programs
- ⤴ Information exchange (publications, social media, etc.)
- ⤴ Annual CACCI Council Meetings and Conferences
- ⤴ Promoting Sustainability
- ⤴ Promoting Entrepreneurship

## **C. HONORARY TREASURER**

The Honorary Treasurer shall be responsible for the financial affairs of the Confederation.

## **D. BUDGET COMMISSION**

The Budget Commission shall be responsible for preparing and presenting the Annual Budget of the Confederation, reviewing the income and expenditures, and formulating ways and means of providing the financial requirements of the Confederation. The Budget Commission shall submit its conclusions and recommendations to the Council for approval.
